## Racing For Change

At the National Prayer Breakfast this month, the keynote address was by NASCAR great, Darrell Waltrip. He told of two racecar drivers, and what made the difference between the two.

The first went at it all the wrong ways. People called him brash, ruthless, pushy, cocky, conceited, aloof, boastful, arrogant, and downright annoying. The fans hated him. The drivers despised him. Richard Petty once told him, "I don't know how you keep a sponsor." His personal life was a mess. He drank too much. He did everything to satisfy himself. That was his lifestyle.

The second was a driver popular with the fans, respected by his competitors.

Waltrip was both drivers. In his words, "In 1983, my horrible wreck knocked me 'conscious.' It was a wakeup call. If I died would I have gone to heaven or to hell? I thought I was a pretty good guy, but good guys can go to hell. I started attending church." In time, with his wife and the preacher, "I got down on my knees and prayed that the Lord would come into my life and forgive me of my sins and be my Lord and Savior."

## Questions and Answers

**Ordinances Continued - Billboard Ordinance Part A**

**Q. When and why was the Billboard ordinance adopted?**

A. This ordinance was first adopted in December of 2001, the first year that I was in office and was in response to the proliferation of billboards along Hwy. 515.

At the time we had no regulations at all for billboards and desired to protect the beauty of our area while at the same time, support business. Just as you entered Union County on Hwy 515 from Blue Ridge and topped the ridge, there is a beautiful view of the mountains that welcomes us all back home when we have been to Atlanta, and is a beautiful way to welcome visitors as well. Unfortunately, one of the 90' high double billboards was placed there, and it really was a distraction to people entering the county.

**Q. How were you able to have this billboard removed?**

A. It was a negotiation process. We had no legal way to force it to be removed since at the time it was erected there were no guidelines or ordinance in place. In preparing our new ordinance, and totally with thanks to the owner of the billboard, he and I were able to negotiate some additional locations in place of this billboard and he completely removed the billboards, thus restoring this beautiful gateway view of our county.

**Q. What is the definition of a billboard according to the ordinance?**

A. It is an advertising sign or a sign which advertises a commodity, product, service, activity or any other person, place or thing, which is not located, found or sold on the premises upon which the sign is located and located along or near state or county highways or county roads or rights-of-way.

**Q. What are the size requirements for a billboard?**

A. Billboards cannot exceed 30 feet in height. Height is measured from the elevation of the road surface of the nearest roadway to the highest point on the billboard. Also, no billboard can exceed an area of 288 square ft. per face. Of course, billboards already in existence at the time were exempt.

**Q. What are some of the other regulations concerning billboards?**

A. All billboards must be located in such a way as to protect

### A no win tax

Dear Editor,

From June 2013 through June 2014, Union County collected \$1,315,858.56 from the local 3 percent sales tax on gasoline alone. County and city collected \$877,239.04, while the schools collected \$438,619.52. Under the proposed Transportation Act of 2015, the county, city, and schools will lose this portion of local option sales tax that is presently used at discretion of local governing authorities once the present splosh tax ends. If this Act becomes law, any local excise tax on gasoline imposed by local authorities will be directed specifically toward roads, bridges, repairs, etc., after the expiration of present splosh taxes.

Under the proposed law, counties can impose 3 cents per gallon on gas without voter approval, as can cities. Example: Union County can impose 3 cents on a gallon of gas; Blairsville can impose 3 cents on a gallon of gas. Any gas sold in the city will have 6 cents of taxes per gallon; any gas sold outside the city will be 3 cents per gallon less. Home rule by cities and counties allow this, without an intergovernmental agreement on excise taxes.

Reminder, the Act now calls it an excise tax, not a sales tax.

With voter approval, county and city can raise an extra 3 cents each per gallon (over and above the 3 cents without voter approval), per

### Papa's Travels

As I advance in years I like to compare my life to the life of Columbus Cummings. We both had two sons and both had careers in agriculture. We both enjoyed seeing new places and experiencing new things. However, during Papa's early years, life was much more difficult. Traveling was particularly difficult. During World War II, Papa was actively engaged in farming. So, the Draft Board skipped over him when his number came up for the draft. He was told the country needed his cotton more than him. He was at home; however, things were extremely difficult for the young family during the winters.

So, after the cotton was harvested in early October, Papa hitched a ride to Phil Campbell where he caught a train to Miami, FL. Papa's older brother, Pickens, secured a job for him milking cows on a large dairy just north of Miami. Papa worked for just over a month when he received word that his youngest son, Bud, was sick with pneumonia. It was difficult to even send a message in those days. Granny had to send a relative 20 miles to Russellville where the nearest phone was located. That relative called the operator in Miami. The operator found someone to take the message out to Papa at the dairy.

Papa had very little money because he was sending it home to Granny and his two sons. So, he had to hitchhike his way from Miami to Phil Campbell. It took him more than a week. By the time Papa got home Bud was much better and on his way to recovery. Papa vowed to never leave his family alone again. He said, "We always had plenty of food. We just never had any money".

Papa also worked harder than I ever thought about. He owned a 300-acre farm in North Alabama that he cleared by hand. The whole farm was in trees when he purchased the land. Papa told me that he and Granny were just married when a man came to see his daddy. This fellow was a banker and storeowner in Phil Campbell. He told his friend Lon that he had a piece of property that the Cummings boys needed to buy. So, a deal was negotiated and Papa, Pick, Clay and Hollis WeHunt each purchased 80 acres of timber from this man. The land was purchased on credit as Papa termed it.

Papa and Granny cut the timber with a crosscut saw. Then they plowed and planted their crops around the stumps. Papa said he had a cleared field in 5-6 years. Over the next few years Papa paid for his land with money he made cutting timber and planting cotton. Then quietly Papa purchased the property each of his brothers had purchased in the original agreement. Papa told me that he had invested \$8,000 in the origi-

## Oh, Nuts!

I recently laid eyes on an interesting internet post on the Lady Bird Johnson Wildflower Center website. It was a question posed to their expert they've dubbed "Mr. Smarty Pants". The question came from a fellow resident of the North Georgia Mountains.

She asked Mr. Pants what plants would do well in her new "forest food garden". She wanted more specifically to know which edible fruit, nut, berry, herb and creepers would be best for this reddish, clay-like soil.

Well I wasn't familiar with this type of garden, and my curiosity was peaked. Technically speaking, forest gardening is a low-maintenance sustainable plant-based food production and agro-forestry system based on woodland ecosystems, incorporating fruit and nut trees, shrubs, herbs, vines and perennial vegetables which have yields directly useful to humans. Yeah, I didn't understand most of that jargon, either.

Easier to understand, forest gardening, in general, has three primary practical intentions: 1. High yields of products such as food, fuel, fiber, fodder, fertilizer, 'farmaceuticals' and fun; 2. A largely self-maintaining garden; 3. A healthy ecosystem. I could get into gardening with these goals in mind, couldn't you?

Edible forest gardening is not necessarily gardening in the forest. It is gardening "like" the forest. You don't need to have an existing woodland if you want to forest garden, though you can certainly work with one. Forest gardeners use the forest as a design metaphor, a model of structure and function. It is a fascinating concept, which I would encourage you to Google if you have any interest in a different and unique conception of gardening. Even if you don't want to raise your garden to these lofty objectives, you'll at least be interested in hearing the answer Mr. Pants shared with the Newbie Forest Gump(ton).

In our "neck of the woods", our edible fruits are the Eastern Persimmon (*Diospyros virginiana*); Pawpaw (*Asimina triloba*); Muscadine Grape (*Vitis rotundifolia*); American Plum (*Prunus americana*); Black Cherry (*Prunus serotina*);
