chapter.  
**Q. Who is responsible for enforcing the Animal Ordinance?**

A. Enforcement of this ordinance is the responsibility of the Union County Sheriff's Office who has assigned two deputies to animal control duties. They both have experience in this area and do an excellent job. If you are on Facebook you can "like" them and get daily updates on their activities. They post updates on lost and found animals and make every effort to reunite pets with their owners. If you need to call them their number is (706) 439-6052. As they are out in the field much of the time you may need to leave a message which they will respond to.

**Q. Does Union County have a leash law?**

A. No, our ordinance does not require sterilized animals be kept on a leash. However, it is the duty of every owner to exercise reasonable care and take all necessary steps and precautions to protect other people and property from injuries and damage which might result from an animal's behavior. Every animal must be restrained or controlled so as to prevent it from chasing vehicles or chasing, menacing, attacking or biting or injuring persons or other animals, or barking excessively.

**Q. What about unsterilized animals. Are they allowed to run loose?**

A. No, they are not. Every owner of an unsterilized

dog, cat or ferret, is required to confine the animal at all times. Any time an unsterilized animal is not confined, the animal must be on a secure and sturdy leash while being walked by a responsible person. Any unsterilized animal that is unconfined or not on a leash is subject to citation, confiscation and impoundment, and, in addition to being subject to citation, the owner will be required to have the animal sterilized within 30 days. The burden is on the owner of a sterilized animal to have proof available that the animal is sterilized.

**Q. Are there any exceptions to the ordinance pertaining to unsterilized animals?**

A. Yes. Unsterilized working animals (including show dogs) are exempt from the above confinement requirements while working, but their owners are required to keep such animals under control.

The burden is on the owners to prove the animal was working at the time of the citation. Owners who negligently allow working animals to roam and run free at any time are subject to citation and sterilization under this ordinance.

**Q. What is considered a working dog?**

A. Working dog means and includes, but is not limited to, seeing eye dogs; certified guard dogs; working cattle dogs; dogs whose primary function is hunting; and dogs which compete in conformation, agility or obedience competitions.

the 9-11 terrorist attack on our country, and how his sense of justice filled him with a burning desire to avenge 3,000 innocent deaths and stop further aggression against the U.S. reflected the turning point in his life. I sat through scenes depicting the difficulty of his Navy SEAL training, through which he gained the skills and fortitude needed to protect our servicemen on foreign soil who were there to weed out the leaders of the radical terrorists. And, doing his job well meant that he was transformed into a precision marksman. Upon return to his wife and children between his 4 deployments, he thought he would be able to adjust easily back into the life he once knew. But he slipped further and further away emotionally, because combat has unbelievably life-altering consequences and it took almost as much commitment for him to revert back to the loving husband and father he had once been. Nevertheless, he did work his way through, and was committed to helping other veterans regain their rightful place in civilian life, when he was killed by a severely traumatized veteran he was trying to help.

Be not too fast to judge our young servicemen and women who risk their lives to preserve our safety, because we know not

what choices and decisions they must make in split-second moments of combat. Having served as a volunteer at retreats for wounded warriors and their family members through the Joni & Friends outreach to those who have suffered, I have learned to be sensitive and non-judgmental towards them, and that when one member of the family is "wounded," the entire family is wounded as well. As the movie ended, there were clips of the 4-hour funeral procession in rainy weather where people lined the route in respect of Chris Kyle's life. I wept for his family, and all the families who have lost a loved one whose mission is to keep us safe, and for the cruel words of people who are unable to comprehend this type of commitment.

Do I wish my son was not in the military? Yes, and even more—do I wish there was no need of a military? Of course! But in the real world in which we live, such answers are not sufficient, so I am proud of a son who realizes he has a duty to perform. He, along with all branches of our military are in my prayers, and I covet the prayers of all who care about our country to pray for the safety and wisdom of our armed forces.

**Letter to the Editor:**

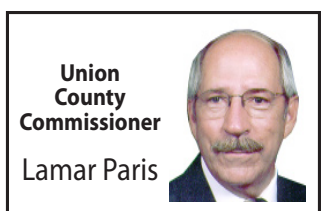
George Mitchell placed a letter to the editor last week about property tax rates that was very misleading and I want to address his letter.

Mr. Mitchell said, "There are 159 counties in the state of Georgia. These 84 have lower tax rates than Union County." He went on to say, "These 2015 figures are based on the average property taxes for a \$165,000 single family home. Union County does not have one of the four or five "lowest tax rates" in Georgia" as I claim. He then went on to provide a few examples which I will compare with the real numbers.

First Union County Government does have the third lowest property tax rate in the state of Georgia. Union County Schools have the second lowest property tax rate in the state of Georgia, and when you combine both the county and school, which is the amount that you pay your property tax bill on, we are the second lowest property tax rate in the State, not 84th as Mr. Mitchell would like to have you believe. That is a big difference.

Mr. Mitchell refers to an average tax, but there is no average tax in a county on a specific valued home. It is a specific number and always will be. For simplicity's sake, we will use Mr. Mitchell's number of a home valued at \$165,000. To figure your property taxes from your property tax rate: \$165,000 x 40 percent (Georgia only taxes you on 40 per cent of your value). Therefore you will pay property taxes on \$66,000. (This assumes no exemptions). To determine your property taxes you simply multiply \$66,000 times the mill rate (property tax rate) of 17.681 mills (Union County combined school and county mill rate). In our case \$66,000 x .017681 = \$1,167.

Mr. Mitchell says Clay County, GA is one of the lowest in the state. Clay County has a mill rate (property tax rate) of 28.635 mills. So if you pay property taxes on a \$165,000 home in Clay County, your same home you pay \$1,167 in Union County would cost you \$1,819 in Clay County, GA (over 55 percent higher tax). Habersham County which he used, \$165,000 house cost you \$1,686. Gilmer County \$1,684, Lumpkin County \$1,816. The 84th rated county is actually Macon County and this home would cost you \$1,939, Cobb County \$1,954, and Fulton



County \$2,016. In summary, Union County property tax on a home valued at \$165,000 is \$652 (55 percent) less than Clay County, that Mr. Mitchell claims to be one of the lowest in the state. Union County Schools and Union County Government work too hard at keeping our property taxes low to have someone print false information in the newspaper about our property tax rate. By the way, Clay County is located on the Alabama border between Dothan and Eufula, AL. It is a relatively poor county and because of that, their land values are low with small populations. Therefore, they have to charge more property taxes to have services.

Not only does Union County have one of the lowest property tax rates, we also have one of the highest qualities of life of any rural county in Georgia. We have great roads, great facilities, and great employees serving the public. Our school system is ranked in the top five in the state, and we have one of the best healthcare systems (hospital/nursing home) anywhere for a small rural county. Not only do we have a low property tax rate, but we are only able to tax about 52 percent of the county land mass as the rest is owned by the U.S. Forest Service and TVA. So I think we do pretty darn good providing the most services and facilities for the least amount of money.

However, what really separates Union County from the rest, is our people. No where can you find more gracious and caring people who are willing to work together to make this a better place to live. I do get frustrated when a few people are so critical of our county and school system. We are all striving to be the best. Certainly we are not going to make everyone happy, but it is hard to imagine that someone would not want to live here and it is very unfortunate that a very few, who have moved here, seem to never be satisfied.
